- 3 CURRENT HANDICAPS TO APPLY
 FORMAT = WINNERS OF MATCH 1 PLAY WINNERS OF MATCH 2 AND SO ON
 SEMI FINALS WILL BE ON NEUTRAL TABLES
- 4 WINNERS TO PHONE OR TEXT CHRIS HILL IMMEDIATELY AFTER THE MATCH
 ON 07941 498308 FAILURE TO DO SO WILL RESULT IN DISQUALIFICATION
- 5 THERE WILL BE NO POINTS START BETWEEN EACH DIVISION
- 6 IN EVENT OF A TIED FRAME , BLACK MUST BE RE-SPOTTED AND THE SEVEN POINTS MUST COUNT TOWARDS TEAM AGGREGATE SCORE.
- 7 FROM THE SEMI-FINALS TEAM CAPTAINS WILL WRITE THEIR FIRST TWO PLAYERS ON SEPARATE SCORE CARDS THEN MATCH THEM UP,REPEAT FOR THE SECOND TWO PLAYERS AND THEN FOR THE FINAL TWO PLAYERS
 TEAMS WILL REFEREE AND BREAK OFF ON ONE TABLE EACH
